 - a. Senator Doyle stated that the Revenue Fund accomplishes goals that the SGLC has set for itself over a period of time.  - President Drescher asked what the LUC Plan for 2020.

- G. Fall SBR Report (**Senator Doyle**)
 - 1. Senator Doyle stated that decision letters go out tomorrow. They had a \$135,600 budget, \$50,301.59 was requested, and \$27,881.08 was approved. This was an approval rate of 55.4%. This is an average approval rate in a normal year. The committee worked with the information given to them by SAGA and Loyola about in-person events. However, a lot of the requests did not follow the guidelines, which led to many of them being denied. They did not want students to be eating food at events for various reasons. They did fund a few grab-and-go events where students were not eating at the event. With off-campus events, they are working with SAGA on the contracts because there as to be someone accountable. Until administrators figure it out, it is out of our hands. There were also some issues with documentation.
- H. Budget Report (CFO Bello)
 - 1. CFO Bello showed the budget.
 - 2. CFO Bello stated that we are starting to see a few initiatives that kicked up this semester. We are nowhere near done using our budget. We can look at this as an opportunity to do a lot of good spending for the student community that we could not do previously. Look at the committee funds and see whether or not there is a way to use those funds. If you don't think you can, there is a possibility of using all of those funds and spending something together through Senate Discretionary. There are three proposed spending requests that might happen. If you have any initiatives, please let him know.
 - 3. Senator Doyle stated that one initiative that President Drescher and her have been working on is to use the funds to purchase furniture for the BCC office.
 - 4. President Drescher stated that this budget remains till July 1st. For those of you who intend to return, we will depend on you to follow through on some of these things.
